- I understand that I will not be added to the 2020 Spring/Summer CSA member list until I have completed the application forms and submitted them, either in person, by mail or by email and total payment has been received by White Oak Valley Farm. Payment in full is due within 7 days of submitting this form.

- By signing up for White Oak Valley Farm's 2020 Spring/Summer CSA, I am committing to the entire 16 week season. I understand that it is important for me to be present each week on my chosen day, time, and location to promptly pick up my CSA box. In the event that I cannot pick up my box on a particular day due to vacation and/or special
- circumstances, I will notify the farm at least 24 hours in advance. The farm will do their best to arrange an alternate pick-up time for me. If an alternate time cannot be worked out, I will either send a friend, neighbor, or family member to pick-up my box, or miss that week's CSA box. Missed CSA boxes cannot be made up at the end of the season, and are not eligible for a refund.

- I understand that missing a CSA pick-up without giving White Oak Valley Farm prior notification, will result in the loss of that week's CSA box. Missed boxes will not be held for later pick-up as your farmers want to always insure that you receive the freshest food possible. Missed boxes cannot be made up at the end of the season and refunds for missed boxes are not offered.

- I understand that if at any time during the season, I wish to forfeit my share, it is my responsibility to find a replacement to take over my share for the remainder of the season. Once payment has been made for my CSA share, no refunds will be issued. (We are unable to offer refunds as we invest your CSA subscription fee into seeds, fertilizer, equipment, etc. at the beginning of the season in order to provide you the very best foods possible throughout the upcoming growing season.)

White Oak Valley Farm's CSA Membership Policy, Terms & Conditions

By signing up for White Oak Valley Farm's Spring/Summer 2020 CSA, you are committing to an entire 16 week season. Once your subscription fee has been paid, no refunds will be granted for any reason. We respectfully ask that once your pick-up day and location has been selected, please make every effort to stick with that day/time/location throughout the entire season. We plan our harvest & delivery schedule carefully to insure that our customers receive the freshest foods possible, and customers frequently switching days/locations makes that job very difficult for us. If you find that you need to change your pick-up day/location, please give us at least 7 days notice. If you are unable to pick-up your box one week due to vacation and/or special circumstances, please make every effort to give us 24 hours advance notice. As is possible, we will try to arrange an alternate pick-up date/time for you within the next 7 days. If that is not possible, please send a friend, neighbor, or family member to pick up the box for you. Due to the nature of our products, missed boxes will not be held or reserved for a later pick-up.

If for some reason, you miss a CSA pick-up without giving prior notification, that week's CSA box will be forfeited. We are unable to hold CSA boxes for delivery at a later date. Missed boxes cannot be made up at the end of the season, and are not eligible for a refund.

We will make every effort to provide you, the customer, with the freshest and the best food possible. Each box will be filled with a variety of vegetables, herbs, and fruits, depending on the season and availability. The exact types of produce available each week will depend on seasonal and environmental factors. As CSA members, you will share in any surplus we harvest, but will also assume some risk related to the farming season. We will guarantee you a regular weekly supply of farm fresh, locally grown produce throughout the CSA season. In the event that we experience a crop failure or extreme weather event that prevents us from harvesting one or more crops, and to increase variety in the CSA boxes, we may occasionally purchase produce from neighboring or other local family farms to insure that you continue to receive a plentiful variety of the freshest produce available in each box.
